**ORDER SCHEDULE**

**METHOD OF PAYMENT**

- We accept checks and ACH Payments for no fee. PayPal QR code payments accepted for a 2% fee. Mastercard, Visa, Discover, and American Express are also accepted for a 3% fee.
- Returned checks, disputes and chargebacks will be charged a \$35 fee.

**CANCELLATION POLICY**

- Orders cancelled by the exhibitor more than 10 days prior to the delivery date will be charged 50% of the original price and the balance will be refunded to the customer.
- Orders cancelled by the exhibitor within 10 days of delivery date will be charged 100% of the original price. There will be no refunds for any order cancelled within 10 days of delivery rate regardless of the cancelation reason.
- In the event of show cancellation by the promoter, the exhibitor will receive a full refund of rental payment.
